**Invitation to Bid for Proposed Construction of One (1) Storey- Three (3) Classrooms School Building (With Common Toilet), One (1) Storey-Two Classrooms School Building (With Common Toilet) and Repair and Rehabilitation of Various School Building-Three Classrooms**

1. The Schools Division Office of Silay City, through the CY 2022 Quick Response Fund intends to apply the sum of **Fourteen Million Five Hundred Fifty-five Thousand Sixty and Eighty-nine Centavos (Php 14, 555, 060.89)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of One (1) Storey- Three (3) Classrooms School Building (With Common Toilet), One (1) Storey-Two Classrooms School Building (With Common Toilet) and Repair and Rehabilitation of Various School Building-Three Classrooms at Guimbala-on Elementary School Project Identification Number(2022-09-SB-001)**. Bids received in excess of the ABC per school shall be automatically rejected at bid opening.
2. The Schools Division Office of Silay City now invites bids for the above Procurement Project. Completion of the Works is required for **Two Hundred Forty Calendar Days (240 cd)**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary **“pass/fail”** criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from Schools Division Office of Silay City BAC Secretariat located at CID Office, and inspect the Bidding Documents at the address given below from 8:00am – 5:00pm, Monday to Friday.
5. A complete set of Bidding Documents may be acquired by interested Bidders on October 7, 2022 from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-five Thousand Pesos (Php 25,000) only*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *and It may also downloaded free of charge from the website of the Procuring Entity, <https://depedsilaycity.weebly.com>*, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The Schools Division Office of Silay City will hold a **Pre-Bid Conference<sup>1</sup> on October 6, 2022 at 9:00 A.M. at the Division Conference Hall**, and/or through videoconferencing, which shall be open to all prospective bidders.

<sup>1</sup> May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.


- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **9:00 a.m., October 19, 2022**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on **October 19, 2022, 9:00 am** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
